Sir,

I am writing in reference to the subject mentioned above, which pertains to your esteemed office's receipt of a grievance referenced as AYUSH/E/A/23/0000166. The grievance in question was as follows:-

"RCC Institute of Information Technology (A Unit of RCC Institute of Technology, An autonomous society of Dept. of Higher Education, Govt. of WB) where candidate has to produce a physical fitness certificate from the Registered Medical Practitioner (Minimum MBBS) before joining. They don't allow BAMS doctors to issue Medical certificate".

I would like to inform you that we have promptly addressed this issue and rectified the inadvertent mistake that occurred due to our lack of awareness regarding the relevant notification. We have taken corrective action by updating the notification on our official platform. This update acknowledges that medical fitness certificates issued by practitioners of Ayurveda, Unani, Siddha, and Sowa-Rigpa are recognized forms of medical fitness certificates.

We apologize for any inconvenience caused and appreciate your vigilance in bringing this matter to our attention. We are committed to ensuring fairness and inclusivity in our processes.
