Kind Attention: All candidates/institutes participating in PG-Counseling, 2023 are informed in respect of submission of following mandatory documents at the time of reporting at the allotted institute.

i. **Twelve months Compulsory Rotatory Internship Completion Certificate:**

Candidates who have not completed their **Twelve months Compulsory Rotatory Internship** at the time of admission/reporting for Round-1 and Round-2 of PG counseling are instructed to submit an Undertaking (**Annexure-I**), counter-signed by the Head of the Institution (the institution from where internship is being pursued). Further, such candidates must submit their original Compulsory Rotatory Internship Completion Certificate at the allotted institute **on or before the last date for reporting to the allotted institutes specified by the respective counseling authority for 2nd round of PG counseling.** Otherwise, his/her admission shall stand cancelled. The vacant seats thus arisen shall be added to 3rd round counseling.

ii. **BAMS/BUMS/BHMS/BSMS Degree Certificate/Provisional Degree Certificate .**

If a candidate not able to produce a valid Provisional Degree Certificate due to non-completion of Internship at the time of admission/ reporting for Round-1 and Round-2 of PG counseling, in that case, the candidate shall submit an undertaking stating that **he/she will submit the valid Provisional Degree Certificate at the allotted institute on or before the commencement date of PG course (i.e. 01st December, 2023) for the academic session 2023-24** as already informed by NCISM/NCH.

iii. **Permanent Registration Certificate** issued by NCISM/ NCH/ CCIM/ CCH /State Ayurveda/Siddha/Unani/Homoeopathy Board:

Candidates who have not completed their **Twelve months Compulsory**

Rotatory Internship at the time of admission/ reporting for Round-1 and Round-2 of PG counseling, are instructed to submit a copy of the **Provisional Registration Certificate** at the time of reporting. Further, such candidates shall submit their original Permanent Registration Certificate **at the allotted institute on or before the commencement date of PG course (i.e 01st December, 2023) for the academic session 2023-24** as already informed by NCISM/NCH.

iv. **Transfer Certificate/College Leaving Certificate:**

Candidates who have not completed their **Twelve months Compulsory Rotatory Internship** at the time of admission/ reporting for Round-1 and Round-2 of PG counseling, are instructed to submit an undertaking stating that **he/she will submit the Transfer Certificate/College Leaving Certificate on or before the last date for reporting to the allotted institutes as specified by the respective counseling authority for 2nd round of PG counseling at the allotted institute.**
