## **Refund & Cancellation Policy**

### • Introduction:

In exercise of the power conferred of the NCISM Act, 2020 & Establishment of New Medical College, opening of new or higher course of study or Training and increase of admission capacity by a medical college Regulation, 2019 the concerned Trust /ASUS colleges need to submit visitation & digitization fee, security deposit, application fee and any other imposed penalty amount that are mandate as per the Concerned Acts & Regulation.

### · Application Fee :

The Application fee once submitted along with all the necessary documents by a way of demand draft or online payment to the NCISM is a non refundable under any circumstances .

## Fixed Security Deposit:

The concerned Trust / ASUS colleges need to submit **Fixed Security Deposit** in favour of the NCISM valid for five years / three years as the case may be as per the Regulation (6) of (13A) Regulation dated 11<sup>th</sup> July, 2019. (It shall not apply to the colleges governed by the state Govt. or Union Territories.)

### Visitation & Digitization Fee :

The Visitation & Digitization Fee to be charged from the ASUS colleges is to be submitted from each and every college per year as case may be.

#### Imposed Monetary Penalty:

In Exercise of the power conferred under Section 29 of the NCISM Act, 2020 the imposed monetary penalty amount is to be submitted as the case may be.

#### Excess Payment/Multiple Payment :

In cases where concerned Trust/ASUS colleges has made multiple payments/ excess payments, he / she must send a written request in the covering letter of the Trust / College addressed to the President, MARBISM for refund of the same and after validation NCISM the amount may be may be refunded the amount as the case may be.

## Refund Processing: For excess payment/multiple payments-

- The Refund request is to be submitted within 10 days of excess payment/multiple payment or the case may be.
- Refund will be processed within 21 working days of receiving a written request after validation of the supporting documentation.
- The Refund will be credited back to the original method of payments unless otherwise specified.
