Subject:- Extension of time period for submission of application/scheme to establish a new Ayurveda / Unani/ Siddha / Sowa Rigpa Colleges from the academic session 2027-2028 – reg.

Sir/Madam

It is hereby informed that the last date of submission of application/scheme to establish a new **Ayurveda/Unani/Siddha/Sowa Rigpa College from the academic session 2027-2028** was scheduled from **16th August 2026 to 31st August 2026**. However, the **Medical Assessment and Rating Board for Indian System of Medicine**, NCISM and the Commission is still in receipt of various request letters from the State Governments, The Registrars of University, The Secretary / President of various Trusts informing that they are unable to issue/receive No objection certificate /Consent of Affiliation from concerned the State Government /University which is an essential document.

Therefore, the Medical Assessment and Rating Board decided to extend the date for submission of application/scheme to establish new **Ayurveda/Unani/Siddha/Sowa Rigpa Colleges from the academic session 2027-2028 till 10.09.2026**.

Hence, any Person/Trust/Institution willing to submit an application/scheme for the academic session 2027-2028 **may submit their application/scheme till 10th September, 2026** through speed post, addressed to the President, Medical Assessment and Rating Board for Indian System of Medicine New Delhi in prescribed format along with all the requisite documents as per the **NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda/Siddha colleges and attached teaching hospitals) Regulations, 2024/National Commission for Indian System of Medicine (Minimum Essential Standards, Assessment and Rating for Undergraduate Unani/Sowa-Rigpa Colleges and Attached Teaching Hospitals) Regulations, 2023 and same has also to be uploaded online in the given URL which will soon be uploaded in the website of NCISM i.e www.ncismindia.org.**

Applicant fulfilling the pre-requisite and eligibility criteria shall submit the application/scheme both online and offline along with all necessary attachments as provided in these Regulation.

Further, all necessary documents to be accompanied by depositing the **non-refundable application and processing fee** by way of a demand draft or online payment payable to "The National Commission Fund for Indian System of Medicine" as per the enforced regulation and detail of same is as under-

Application and Processing fees is to be added with 18% GST.

Note:-

1. Any application/scheme received after the stipulated time period will not be entertained in any case.
2. Application shall not be withdrawn after the last date.
3. In case of withdrawal of application before the last date, the processing fee shall be refunded.
4. Any document of regional language shall be submitted with the translated version of Hindi or English duly attested by the competent authority.

5. NOC/COA issued after the last date of submission of application shall not be considered for the Academic year 2027-28 and shall be considered for the academic session 2028-29.
6. Application/Scheme shall be scrutinized on the basis of eligibility criteria like Application Fee, No Objection Certificate of the State Government and Consent of Affiliation of the University etc. and only eligible applications fulfilling all the criteria will be accepted for further consideration and the ineligible and incomplete applications shall not be accepted and shall be rejected and returned to the Person/Trust/Institution.
7. The application shall be processed as per the Regulations in force as on date.
8. Separate notification will be issued for the existing institute to apply for seat increase in existing Course /to start new *postgraduate course* /or seat increase in existing *postgraduate course*.
